## NOTIFICATION

## Corrigendum

The following submission, dated 13 July 2022, is being circulated at the request of the delegation of the **European Union**. The corrigendum concerns the notification of total exports (**Table ES:2**) in the context of export subsidy commitments for the **Marketing Year 2020/2021**.

The present communication introduces the following modifications:

Under Point I "Products from the schedule" for Wheat and wheat flour should be replaced as follows:

• For Quantity of total exports: **27,191.8** thousand tonnes.

Under Point III "Additional products with a share exceeding 5% of total world export" for Wheat and flour should be replaced as follows:

- For Quantity of total exports: **27,191.8** thousand tonnes.
- For product disaggregation: **10019900: 26,666.9** thousand tonnes; **11010015: 524.9** thousand tonnes.
