- The data in column 4 (JPNQ014 and JPNQ015) are the estimates based on the contracted volume, so they will be updated to actually-imported quantity.
- The data in column 4 (JPNQ016) is quantity of successful bids (state trading) and access that was opened up for private imports, and will be updated to actually-imported quantity.
- JPNQ003 and JPNQ005, listed in the Schedule, are not included in the notification, because tariff quota systems are not applied to them. These products can be introduced into Japan under the *Hozei* area (Note) system, without imposed customs duties and required quota certifications, provided that they are used for consumption in the cruise of international maritime vessels and international airlines as described in the Notes to Section I B of Part I of the Schedule. The statistics of imports for these products under the *Hozei* area system are not available.
- Likewise, the quota quantities in column 4 for JPNQ002, JPNQ004, and JPNQ008 do not include quantities available under the *Hozei* area system as described in the Notes to Section I-B of Part I of the Schedule.
- The In-Quota quantities in column 4 for JPNQ014, JPNQ015, and JPNQ016 do not include quantities imported under the Agreement between Japan and Australia for an Economic Partnership, the Comprehensive and Progressive Agreement for Trans-Pacific Partnership, the Agreement between the European Union and Japan for an Economic Partnership, the Trade Agreement between Japan and the United States of America, and the Agreement between the United Kingdom of Great Britain and Northern Ireland and Japan for a Comprehensive Economic Partnership.

(Note) *Hozei* area is the area where collection of customs duties on imports is temporarily reserved.

- JPNQ012: whole milk equivalent.
- JPNQ014: wheat basis.
- JPNQ015: barley basis.
