NOTIFICATION

The following submission, dated 23 March 2015 is being circulated at the request of the Delegation of **Malaysia**. The notification concerns imports under tariff quotas (**Table MA:2**) during the calendar years **1998-2013**.

For the reporting years **1998-2007**, no scheduled tariff quotas were opened and a tariff-only regime (i.e. generally applicable tariff not exceeding the corresponding in-quota tariff in the Schedule) applied for such tariff quota products.

For the reporting years **2008-2013**, the enclosed Table MA:2 notification includes only those tariff quotas in the Schedule that were opened in the relevant reporting years. For the remaining tariff quota products, a tariff-only regime was applicable.

Notes (for all reporting years):

1. The tariff lines included in column 2 are only those which actually formed part of the tariff quota opened in the reporting year. The remaining tariff lines, which are otherwise part of the tariff quota in the Schedule, were subject to a tariff-only regime. In-quota imports in column 4 correspond only to the tariff headings in column 2.
2. In some cases, a tariff quota quantity bigger than the one in the Schedule was opened. In such cases, the actual tariff quota quantity that was opened is indicated in column 3 in bracket. In some cases, imports bigger than the tariff quota quantity actually opened were permitted due to increasing demand.
