**1 QUANTITY OF FOOD ASSISTANCE PROVIDED TO LEAST-DEVELOPED AND NET FOOD-IMPORTING DEVELOPING COUNTRIES**

Norway provides food aid in the form of economic assistance through organizations such as WFP. Norwegian assistance further includes long-term development programmes as well as emergency relief aid. Norway's total contribution to food aid amounted to **NOK 2,153 million** in 2020.

All Norwegian food aid is provided fully on grant terms.

**3 TECHNICAL AND FINANCIAL ASSISTANCE UNDER PARAGRAPH 3(III) OF THE DECISION**

Norwegian development assistance channelled through the World Food Programme amounted to NOK 934 million in 2020. NOK 300 million was multilateral core contributions and NOK 634 million was earmarked contributions.
