NOTIFICATION

The following submission, dated 23 June 2022, is being circulated at the request of the delegation of **Norway**. The notification concerns imports under tariff quotas (**Table MA:2**) during the **Calendar Year 2021**.

The import data in this document provides the Table MA:2 notification for 2021. Both minimum access quotas and current access quotas for meat to promotional fairs, sheep meat, meat of game, cheese, natural honey, apples, pears, hay, turkey roll and corned beef are included in the notification. For other current access quotas included in Norway's Schedule, as of 2000 the bound MFN tariff has been at the level of the in-quota tariff. A tariff-only regime applies to these TRQs from 2000 and onwards. Since Norway has fulfilled its commitments, for the current access quotas with a tariff-only regime, these will not be a part of the notification.

- (3) NORQ032: The import quota for cheese from the European Communities was at 8,101 tonnes. The import quota for cheese from the United Kingdom was at 299 tonnes. In addition, a quota of 200 tonnes for the import of cheese from Switzerland and Iceland was maintained.
- (4) NORQ091: Tariff-quota is open from 1 August to 30 November.
- (5) NORQ092: Tariff-quota is open from 1 to 30 November.
