- (1) Loan managed by the Small Business Financing Agency under the auspices of the Ministry of Finance, Trade and Economic Planning, disbursed through the Development Bank of Seychelles at a preferential rate of 2.5%. The figures represent the revenue forgone in administering the preferential rate as opposed to the prevailing commercial rate of 8.5%.
- (2) Support reflected through a preferential rate of SR 6.50/m² for lease of land for agricultural activities. The figures provided express revenue forgone in administering the preferential rate as opposed to the commercial rate of 30.00/m² over the last year.
