Note:

Land conservation subsidy: Responding to the need to ease restrictions on rice imports and cut agricultural supports in the wake of WTO accession, the COA implemented the "Adjustment Program of Paddy and Upland Field Utilization". This program is steadily adjusting the growing of rice, coarse grains, and contract sugarcane for sale to the government at guaranteed prices, while also offering payments for the maintenance of farmland in environmentally good condition by growing green manure crops or setting-aside. In order to comply with the WTO regulations, the amount of payment is lower than the extra costs or loss of income. The COA provided assistance for fallowing on a total area of 221,679 hectares in 2008. This achieved lower domestic agricultural support goals, while taking into consideration farmland ecology and soil fertility needs.

Land conservation subsidy: Responding to the need to ease restrictions on rice imports and cut agricultural supports in the wake of WTO accession, the COA implemented the "Adjustment of Paddy and Upland Crop Utilization Program". This program is steadily adjusting the growing of rice, coarse grains, and contract sugarcane for sale to the government at guaranteed prices, while also offering payments for the maintenance of farmland in environmentally good condition by growing green manure crops or setting-aside. In order to comply with the WTO regulations, the amount of payment is lower than the extra costs or loss of income. The COA provided assistance for fallowing on a total area of 213,697 hectares in 2009. This achieved lower domestic agricultural support goals, while taking into consideration farmland ecology and soil fertility needs.

Land conservation subsidy: Responding to the need to ease restrictions on rice imports and cut agricultural supports in the wake of WTO accession, the COA implemented the "Adjustment of Paddy Field Multiple Utilization Program". This program is steadily adjusting the growing of rice, coarse grains, and contract sugarcane for sale to the government at guaranteed prices, while also offering payments for the maintenance of farmland in environmentally good condition by growing green manure crops or setting-aside. In order to comply with the WTO regulations, the amount of payment is lower than the extra costs or loss of income. The COA provided assistance for fallowing on a total area of 206,467 hectares in 2010. This achieved lower domestic agricultural support goals, while taking into consideration farmland ecology and soil fertility needs.
