## Corrigendum

The following submission, dated 5 February 2018 is being circulated at the request of the Delegation of **Ukraine**. The corrected notification concerns domestic support commitments (**Table DS:1** and the relevant Supporting Tables) for the calendar year **2011**.

The following corrections should be applied to the original notification G/AG/N/UKR/18 dated 6 February 2014 covering the calendar year 2011:

- in Supporting Table DS:4, the words "Fruits and grape" is changed to read "Fruits, berries and grapes";
- in Supporting Table DS:6, the assignments of the support to the two entries a) hops and b) fruits, berries and grapes were misplaced under "Other non-exempt direct payments" and thus are now excluded from this Table;
- Supporting Table DS:7, the appropriate support is now placed under "Product-specific budgetary outlays".

These corrections do not affect the notified Current Total AMS.
