## NOTIFICATION

The following submission, dated 21 March 2023, is being circulated at the request of the delegation of **Ukraine**. The notification concerns the administration of tariff quotas **(Table MA:1)** for the **Calendar Year 2023**.

The attached notification is submitted pursuant to the obligation to communicate any changes in the administration of tariff quotas, in accordance with the requirements given in document G/AG/2. This notification amends the document G/AG/N/UKR/34, dated 23 August 2019. The change concerns the administration of the tariff rate quota for raw cane sugar and is referred to in item (b) (i) of the notification.

In case of exhausting the set quota, acceptance of requests for delivery of licences is halted. Licences are not transferable.</li> <li>In case of the increase of the value of imports, the licence holder would be required to apply for a new licence. Reducing of the value of import sdoes not require a new licence.</li> <li>In the period not later than 15 days after the date of import licence validity expiring, economic operators should submit to the Ministry of Economy the information on factual import of goods under the licence (indicating amounts).</li> </ul> |      |
