- (1) On 21 July 2022, the United States Trade Representative (USTR) announced, through the Federal Register, allocations of the fiscal year (FY) 2023 (1 October 2022 to 30 September 2023) in-quota aggregate quantity of the raw sugar tariff-rate quota (TRQ) of 1,117,195 metric tonnes raw value (MTRV). This quantity is the minimum amount to which the United States is committed under the World Trade Organization (WTO) Uruguay Round Agreements. Metric tonnes raw value is equivalent to metric tonnes for purposes of this notification.
- (2) Available on a first-come, first-served basis.
- (3) On 19 September 2022, USTR announced, through the Federal Register, allocations of the FY 2023 in-quota quantity of the refined and specialty sugar TRQ of 222,000 MTRV. This includes the 22,000 MTRV minimum amount the United States is committed to provide under the World Trade Organization (WTO) Uruguay Round Agreements. USTR allocated 10,300 MTRV of refined sugar to Canada, 2,954 MTRV of refined sugar to Mexico, and 7,090 MTRV to all countries (global) on a first-come, first-served basis. 1,656 MTRV was reserved for specialty sugar, plus an additional 200,000 MTRV. Imports of all specialty sugar will be administered on a first-come, first-served basis in five tranches. The U.S. Department of Agriculture announced that the total in-quota quantity of specialty sugar will be the 1,656 MTRV reserved within the WTO minimum plus an additional 200,000 MTRV. The first tranche of 1,656 MTRV opened on 3 October 2022. All types of specialty sugar are eligible for entry under this tranche. The second tranche of 60,000 MTRV opened 10 October 2022. The third tranche of 60,000 MTRV opened on 20 January 2023. The fourth tranche of 40,000 MTRV will open on 14 April 2023. The fifth tranche of 40,000 MTRV will open on 14 July 2023. The second, third, fourth, and fifth tranches will be reserved for organic sugar and other specialty sugar not currently produced commercially in the United States or reasonably available from domestic sources.
- (4) On 21 July 2022, USTR announced allocations of the FY 2023 sugar-containing products TRQ of 64,709 metric tonnes, of which USTR allocated 59,250 metric tonnes to Canada. The remaining 5,459 metric tonnes of the in-quota quantity is available to other countries on a first-come, first-served basis.
