## Revision

1. As of 19 May 2017, the ITA has 53 Participants (covering 82 Members and States or separate customs territories in the process of acceding to the WTO) representing approximately $96 \%$ of world trade in information technology products.

If the Participant was a WTO Member at the time of its participation in the ITA, it was required to follow the procedures for the formal rectification and modification of schedules (Decision of 26 March 1980 on Procedures for Modification and Rectification of Schedules of Tariff Concessions, BISD 27S/25) pursuant to paragraph 2 of the Annex to the Ministerial Declaration. 3. As of the above, El Salvador has indicated that implementation would begin after the completion of domestic legal procedural requirements. ${ }^{4}$ Morocco has not yet submitted the formal documentation.
4. Afghanistan; Albania; China; Georgia; Jordan; Kazakhstan, Republic of; Kyrgyz Republic; Moldova, Republic of; Oman; Saudi Arabia, Kingdom of; Seychelles, Republic of; Tajikistan; Ukraine; and Viet Nam incorporated their commitments in their schedules annexed to their Protocols of Accession, and therefore it was not necessary to follow the procedures for rectification and modification of tariff schedules.
5. Letters of acceptance, in accordance with the provision of paragraph 10 of the Annex to the Declaration, have been received from all Participants except five.
