### REPORT (2018) OF THE COMMITTEE ON TRADE FACILITATION TO THE COUNCIL FOR TRADE IN GOODS

- 1. The Committee on Trade Facilitation (TFC) met several times in different formats. Regular Committee meetings were complemented by a dedicated session on assistance and support for capacity building. In addition, Members engaged in consultations led by the TFC Chair.
- 2. On 5 March 2018, Members took part in open-ended consultations on next steps for Committee work on Trade Facilitation.
- 3. The meeting was followed by a regular Committee session on 2 May 2018. It had two main agenda items:
  - i. Matters relating to the implementation and administration of the Trade Facilitation Agreement (TFA). Work under this item focused on notifications by Members, starting with notifications under Articles 15 and 16 of the TFA, followed by notifications under Articles 1:4, 10:4:3, 10:6:2 and 12:2:2 of the TFA. Members also looked at the status of the ratification process and were updated on the latest developments in that area by the WTO Secretariat;
  - ii. Experience sharing/thematic discussions. Under this item, Members shared their experiences on items such as (i) National Trade Facilitation Committees, (ii) transit, and (iii) implementation experiences.
- 4. On 3 May 2018, the Committee held a dedicated session on assistance and capacity building in line with Article 21:4 of the TFA. Discussion topics included:
  - i. Exchanges on any implementation problems;
  - ii. A review of progress in the provision of assistance and support for capacity building to support the implementation of the Trade Facilitation Agreement;
  - iii. The sharing of experiences and information on ongoing assistance and support for capacity building and implementation programs, including challenges and successes;
  - iv. The review of donor notifications as set forth in Article 22 of the TFA; and
  - v. The review of the operation of Article 21:2 (assistance and support for LDCs).
- 5. Immediately after that session, the Committee chairmanship was handed over from Ambassador Daniel Blockert of Sweden to Ambassador Dalia Kadišiene of Lithuania, who was elected by acclamation on 3 May.
- 6. The next meeting of the TFC took place on 26 June 2018. It had three main agenda items:
  - i. Matters relating to the implementation and administration of the Trade Facilitation Agreement. Under this item, the Committee addressed a series of matters relating to notifications by Members. Following a discussion of a proposal on the organization of the agenda, the Committee turned to notifications under (i) Articles 15 and 16 of the TFA, (ii) Articles 1:4, 10:4:3, 10:6:2 and 12:2:2 of the TFA and (iii) Article 22 of the TFA. The Committee was then updated on the status of the ratification and the notification processes;

- ii. Experience sharing/thematic discussions. Under this item, Members shared their experiences on issues such as (i) regional approaches to trade facilitation and (ii) Article 2 of the TFA (opportunity to comment, information before entry into force, and consultations). They also discussed approaches to the planning of future experience sharing among Members;
- iii. Reports on recent and upcoming activities.
- 7. The TFC met again from 9 to 11 October. The agenda of the meeting included the following items:
  - i. Matters relating to the implementation and administration of the Trade Facilitation Agreement. Under this item, the Committee addressed a series of matters relating to notifications by Members. Following a discussion of the organization of the agenda, the Committee turned to notifications under (i) Articles 15 and 16 of the TFA, (ii) Articles 1:4, 10:4:3, 10:6:2 and 12:2:2 of the TFA and (iii) Article 22 of the TFA. The Committee was then updated on the status of the ratification and the notification processes;
  - ii. Administrative Separation Between the Trade Facilitation Agreement Facility and the Committee on Trade Facilitation Request by the United States;
  - iii. Experience sharing/thematic discussions. Under this item, Members shared their experiences on issues such as (i) authorized economic operators, (ii) transit, (iii) single window and (iv) advance rulings;
  - iv. Recent and upcoming activities;
  - v. Draft Annual Report of the TFC to the Council for Trade in Goods (G/TFA/W/10/Rev.1).
