REPORT (2018) OF THE COMMITTEE ON SAFEGUARDS TO THE COUNCIL FOR TRADE IN GOODS

(ADOPTED 22 OCTOBER 2018)

1 GENERAL

- 1. The Committee on Safeguards ("Committee") performs the functions set out in Article 13 of the Agreement on Safeguards. This report is submitted in accordance with Article 13.1(a) of the Agreement, which requires the Committee to report annually to the Council for Trade in Goods on the general implementation of the Agreement. The report covers the period 23 October 2017 22 October 2018 ("period under review").
- 2. During the period under review, the Committee held two regular meetings, on 23 April 2018 (G/SG/M/53) and on 22 October 2018 (G/SG/M/54) and held two informal meetings on 20 June 2018 and on 14 September 2018.
- 3. Observer governments in the General Council of the WTO have observer status in the Committee. Pursuant to their Agreements with the WTO, the IMF and the World Bank have observer status in the Committee as well. UNCTAD has observer status through a Committee decision. At its regular meetings in 1998, the Committee decided to invite the ACP Group and the OECD to attend Committee meetings on an *ad hoc* basis.
- 4. At its April 2018 meeting, the Committee elected Mr Hyouk woo Kwon as Chairperson, and Ms Katherine Dellar as Vice-Chairperson.

2 NOTIFICATION AND EXAMINATION OF SAFEGUARDS LAWS AND/OR REGULATIONS OF MEMBERS

- 5. During the period under review, the Committee continued its review of notifications under Article 12.6 of the Agreement concerning national legislation and/or regulations in the area of safeguards. For Members with such legislation and/or regulations, these notifications consist of the full and integrated text thereof. For Members without such legislation and/or regulations, these notifications inform the Committee of this fact.
- 6. Members that had notified the Committee of their safeguards legislation and/or regulations or made communications in this regard to the Committee are indicated in Annex 1. As of 22 October 2018, twenty (20) Members had not made such a notification. The Chairman reminded the Committee of the importance of such notifications.
- 7. During the period under review, the Committee reviewed the notified (new or amended) legislative texts of the following Members: Brazil, Cambodia, Canada, China and Liberia.
- 8. The substance of the review of legislative notifications is reflected in written questions put to Members and written answers to those questions. References to the questions and answers pertaining to each notification can be found in the minutes of the meetings at which the notifications were reviewed (G/SG/M/53 and G/SG/M/54).

3 NOTIFICATIONS OF ACTIONS RELATED TO SAFEGUARD MEASURES

- 9. During the period under review, the Committee received and reviewed a variety of notifications of actions related to safeguard measures. The notifications of initiations, the application of safeguard measures, and the termination of investigations without measures received by the Committee during the period under review are summarized in Annex 2. A record of investigations underway and measures applicable as of 22 October 2018 is set forth in Annex 3.
- 10. Members' comments concerning these notifications can be found in the minutes of the meetings at which they were reviewed (G/SG/M/53 and G/SG/M/54). Members' written questions and answers concerning these notifications can be found in the G/SG/Q2/... series.

4 US MEASURES ON STEEL AND ALUMINUM

11. At its April 2018 and October 2018 meetings, at the request of one Member and 4 Members respectively, the Committee discussed the US measures on steel and aluminium.

5 ADDITION OF CERTAIN INFORMATION INTO THE ANNUAL REPORT

12. At its April 2018 meeting, the Committee continued to discuss an idea proposed earlier by a Member regarding the inclusion of the timing of the notification of key actions taken under Article 12.1 of the Agreement into the relevant annex of the Annual Report. At its October 2018 meeting, the Committee found a way forward that was agreeable to all Members, and the Chairman asked the Secretariat to prepare the 2019 annual report in line with the format agreed.

6 REQUEST UNDER ARTICLE 13.1 (E) OF THE AGREEMENT

13. On 15 March 2018, Thailand submitted a request under Article 13.1 (e) of the Agreement concerning suspension of concessions by Turkey. The Committee discussed this request at its April 2018 meeting, at two informal meetings held on 20 June 2018 and on 14 September 2018, and at its October 2018 meeting. At the meeting of October 2018, after more discussions, Members had no more comments on the draft, and the chair decided to submit a factual report to the Council on Trade in Goods under his own responsibility.¹

7 STATUS OF A SAFEGUARD INVESTIGATION BY UKRAINE

14. At the April 2018 meeting, a Member wished to clarify the status of an investigation by Ukraine. Ukraine explained the latest situation.

8 TREATMENT OF DEVELOPING COUNTRIES AND NOTIFICATIONS PERTAINING TO ARTICLE 9 OF THE AGREEMENT ON SAFEGUARDS

15. At the April 2018 meeting, a Member suggested that the existing mechanism under the Agreement could be improved to increase transparency and legal certainty for developing country Members who were exporters to a country imposing a SG measure.

9 DISCUSSION GROUP REGARDING SAFEGUARD PROCEEDINGS

16. At the April 2018 meeting, a Member, on behalf of 11 other Members, explained that a meeting of an informal discussion group regarding safeguard proceedings would take place after the Committee meeting. While it was not part of the Committee meeting, the discussion was open to all Members. The idea behind this discussion group was to provide a broader perspective than the one in normal Committee meetings, removed from discussions of individual cases, and to focus more on each other's experiences and to learn from each other. The topics were: (i) notifications under Article 12 and (ii) reports of findings and public disclosure.

10 OTHER ISSUES RAISED

17. At the meeting of April 2018, there was no item raised under "Other Business". At the October 2018 meeting, two Members raised concerns regarding an investigation conducted by a Member on powdered milk and Gouda cheese, notified in March 2018; four Members raised concerns regarding an investigation conducted by a Member on certain steel products, notified recently; and the Chairman made two announcements.
