**REPORT ON IMPROVEMENTS IN THE FUNCTIONING OF  
THE COUNCIL FOR TRADE IN GOODS AND ITS SUBSIDIARY BODIES<sup>1</sup>**

**1 INTRODUCTION**

1.1. The Council for Trade in Goods (CTG or Council) began its discussions on WTO Reform in September 2022, following the mandate set out in the MC12 Outcome Document<sup>2</sup>, which instructed the General Council and its subsidiary bodies to "conduct the work, review progress, and consider decisions, as appropriate, to be submitted to the next Ministerial Conference". This report provides information on the discussions to improve the functioning of the CTG and its 14 subsidiary bodies, which collectively implement all the agreements for trade in goods included in Annex 1A of the WTO Agreement, and represent the majority of the WTO's regular bodies. It reflects all the improvements realized since the conclusion of MC12, and is based on the individual reports prepared by each of these bodies or their Chairpersons, as applicable (see Annex 1).

1.2. The CTG is pleased to report that a total of 127 improvements have been introduced in the functioning of the CTG and its subsidiary bodies, including 67 changes which have been formally adopted by these bodies and 60 changes where either the Chairperson or the Secretariat has taken action following discussions with Members. A summary of the number of improvements by body is provided in Table 1 in Section 3 of this document (see below). This work is significant insofar as the effective functioning of the regular bodies is a necessary condition for a successful implementation of the existing WTO Agreements, including the mandate and terms of reference of these bodies, in addition to any other substantive change adopted in the context of the broader WTO reform discussions. Improving the functioning of regular bodies is an incremental process, and Members may wish to continue relevant discussions in the future, if necessary, based on inputs from Members.

1.3. Section 2 of this report describes the process followed by the CTG in implementing this mandate, and the proposals adopted or recommended by the Council, as well as the role it has played *vis-à-vis* its 14 subsidiary bodies. Section 3 then reproduces, by area or category, the main outcomes of these discussions.

**2 PROCESS AND PROPOSALS**

2.1. At the Council's formal meeting of 7-8 July 2022, the Chairperson of the CTG recalled a document<sup>3</sup> that had been prepared by the Secretariat listing the outcomes of MC12, and noted that there were three elements that seemed to relate to the work of the Goods Council, namely: (i) the "Work Programme on Electronic Commerce" ([WT/MIN\(22\)/32](#)); (ii) paragraph 24 of the "Ministerial Declaration on the WTO Response to the COVID-19 Pandemic and Preparedness for Future Pandemics" ([WT/MIN\(22\)/31](#)); and (iii) paragraph 3 of the MC12 Outcome Document ([WT/MIN\(22\)/24](#)), on WTO Reform, which concluded by stating: "While reaffirming the foundational principles of the WTO, we envision reforms to improve all its functions." On this basis, the Chairperson announced that he would hold bilateral consultations to hear Members' views and plans in respect of these issues, and stressed that, to this end, his door remained open.

2.2. On 14 October 2022<sup>4</sup>, the Council met informally to allow the Chairperson to report on the outcome of his consultations.<sup>5</sup> On WTO reform, the Chairperson reported that all Members he had

met had insisted on the need to have a process that was open, inclusive, transparent, and Member-driven. They further considered that, since the Council oversees most Committees, it could have an important role to play when discussing how to improve the deliberative function of the WTO. However, the Chair also noted that Members seemed to disagree on whether these discussions should be undertaken as a top-down, or a bottom-up process, a difference of views which had also been expressed at this meeting.<sup>6</sup> At the meeting, and with a view to better understanding the current status of work in the different bodies, the Chairperson was also requested to write to the Chairpersons of the 14 subsidiary bodies to ask them to prepare a report, under their own responsibility and with the Secretariat's assistance, describing the current functioning of their committees, including actions previously taken to improve their work.<sup>7</sup> Finally, Members asked the Secretariat to organize an information session for delegations to better understand the digital tools used by the CTG and its subsidiary bodies. The session was held in December 2022.<sup>8</sup>

2.3. The reports by the Chairpersons of the CTG and its 14 subsidiary bodies describing the current functioning of their respective bodies were circulated by the end of 2022. At the CTG's formal meeting of 24-25 November 2022, Members requested the Secretariat to prepare a document or summary to assist them in comparing the information that had been provided in these reports.<sup>9</sup>

2.4. At the informal meeting of 31 January 2023<sup>10</sup>, the Chairpersons of the 14 subsidiary bodies presented their respective reports on the current functioning of their Committees<sup>11</sup>, and the Secretariat introduced a "comparative matrix"<sup>12</sup>, which provided a general overview of these reports. At this meeting, Members continued to disagree on the role to be played by the CTG with respect to the work of its subsidiary bodies. The Chairperson concluded by noting that, while the CTG would continue reflecting on the improvements that it would like to introduce in its own functioning, it remained subject to the decision of each subsidiary body to discuss if, when, and how they would like to improve their own work, taking into account the comparative matrix.<sup>13</sup> On a separate issue, and following a proposal by Members, the Chairperson noted there appeared to be convergence to follow written procedures to adopt a decision for the introduction of the eAgenda for the CTG on a trial basis.<sup>14</sup>

2.5. At the informal meeting of 27 February 2023<sup>15</sup>, Members discussed the areas of CTG work that required improvement and the process to be followed. Based on these discussions, the Chairperson of the CTG prepared a communication which included a preliminary list of issues that had been proposed for discussion, and invited Members to provide additional inputs.<sup>16</sup> On the role of the CTG *vis-à-vis* the subsidiary bodies, the Chairperson was asked to send a communication to the Chairpersons of these bodies asking them to organize discussions concerning the functioning of their bodies and noting that, at a later stage, they would be requested to report back to the CTG on their discussions and describe the improvements that they had introduced, if any. This communication was sent on 9 March 2023.<sup>17</sup>

2.6. At its informal meeting of 31 March 2023<sup>18</sup>, Members were asked to react to the "Preliminary List of Issues Proposed for Discussion" contained in the Annex to the Convening Notice in [ICN/CTG/9](#). Under the responsibility of the Chairperson, a document containing a table indicating the status of the discussions on each of the proposals was circulated after the meeting.<sup>19</sup> In this document,

Members were also asked to consider the adoption at the Council's following formal meeting of three improvements, which were subsequently agreed on at the formal meeting of 3-4 April 2023.<sup>20</sup>

2.7. At the CTG's informal meeting of 31 May 2023<sup>21</sup>, Members were invited to focus on those issues that had been highlighted as requiring further discussion. Following this meeting, the table on the current status of work was updated to reflect the key developments.<sup>22</sup> In addition, the Chairperson reported on the status of discussions at the formal meeting of 6-7 July 2023.<sup>23</sup>

2.8. At the CTG's informal meeting of 19 September 2023<sup>24</sup>, the Chairperson urged Members to try to advance as much as possible in their discussions on MC12 implementation matters in order to report back at the last formal meeting of the CTG<sup>25</sup> before the 13<sup>th</sup> Ministerial Conference (MC13).<sup>26</sup> Following this informal meeting, an updated version of the table with the status of the proposals was circulated in [JOB/CTG/37](#), and a written procedure was launched with a view to formally adopting five additional improvements.<sup>27</sup> Since no objection was raised, the five proposals were adopted on 2 October 2023 (see [G/L/1490](#)).

2.9. In the context of these discussions, the Council has considered more than 30 specific proposals, including the following written proposals:

- a. Functioning of the CTG and its Subsidiary Bodies, Communication from Argentina, Brazil, Colombia, Ecuador, Paraguay, Peru and Uruguay ([JOB/CTG/21/Rev.3](#));
- b. Compilation of Input on the Functioning of the Goods Committees, Communication from the United Kingdom ([JOB/CTG/26/Rev.1](#)); and
- c. "List of Issues where there Appears to be a Consensus that they should be Addressed in all CTG Subsidiary Bodies", Communication from Argentina ([RD/CTG/19](#)).

2.10. At the CTG's formal meeting of 30 November 2023, the Council adopted on a trial basis four additional improvements (see [G/L/1522](#)), and recalled the importance of complying with paragraphs 4 and 7 of the "Guidelines on the Arrangements for Scheduling of Meetings of WTO Bodies" (document [WT/L/106](#)) concerning the desirability of fixing the dates of formal meetings in advance of the following calendar year, and submitting a written notice explaining to Delegations the reasons behind cancellations or postponements of meetings.

2.11. The process followed by each of the CTG's subsidiary bodies, including links to the written proposals submitted by Members, is described in their reports, as listed in Annex 1 below.

### **3 IMPROVEMENTS IN THE FUNCTIONING OF THE CTG AND ITS SUBSIDIARY BODIES**

#### **3.1 Overview**

3.1. As a result of the above-mentioned process, the CTG agreed to implement 22 changes with a view to improving its functioning, including 9 adopted through formal decisions and 13 where the Secretariat introduced changes to the way in which it supports the work of the Council following discussions with Members. In addition, the CTG's 14 subsidiary bodies have agreed to 99 additional improvements, adding up to a total of 127 changes overall by the 15 bodies covered by this report. The specific number of improvements by each of these bodies is summarized in Table 1 below.

### 3.2 Types of improvements introduced

3.2. The improvements on the functioning of the CTG and its subsidiary bodies can be categorized into six areas or categories that were used by most of these bodies in discussing the proposals. This section provides an overview of the improvements in these areas by each of the 15 bodies covered by this report. The tables should not be interpreted as an inventory of the practices currently applied by all these bodies, but rather as a list of the changes that have been agreed or implemented since the conclusion of MC12 (i.e. some bodies were already implementing these measures). Because some of the changes described in the reports submitted referred to more than one of these categories, they were repeated under the relevant sections with a view to having a comprehensive overview of each area. Finally, it should be noted that the implementation of some of the measures that were approved or requested in these bodies are subject to budgetary constraints.

#### 3.2.1 Assistance to delegates

3.3. The following improvements were introduced by the CTG and its subsidiary bodies with a view to assisting delegates to better participate in the work of these bodies.

3.4. The following improvements were introduced by the CTG and its subsidiary bodies with a view to improving the planning and organization of meetings.
