**TWELFTH BIENNIAL REVIEW OF THE IMPLEMENTATION AND OPERATION  
OF THE AGREEMENT ON IMPORT LICENSING PROCEDURES<sup>1</sup>**

Article 7.1 of the Agreement on Import Licensing Procedures provides that "the Committee shall review as necessary, but at least once every two years, the implementation and operation of this Agreement, taking into account the objectives thereof, and the rights and obligations contained therein".

The main objectives of the Agreement are those listed in the preamble of the Agreement.

The information contained in this document covers the period from **22 October 2016 to - 22 October 2018**.

## 2 WORK OF THE COMMITTEE DURING THE REVIEW PERIOD (2017-2018)

### 2.1 Formal Committee meetings

2.1. In the two years under review, the Committee held four formal meetings, on 5 May and 3 October 2017, and on 20 April and 22 October 2018. The minutes of these meetings are contained in documents G/LIC/M/45-G/LIC/M/48, respectively.

2.2. At the formal meetings, the Committee: (i) reviewed Members' notifications under various provisions of the Agreement; (ii) exchanged views on specific trade concerns raised by Members through written questions and replies as well as through oral statements; (iii) reviewed and adopted its annual reports to the Council for Trade in Goods for 2017 and 2018, in accordance with Article 7.4 of the Agreement (G/L/1187 and G/L/1269); (iv) carried out the 12<sup>th</sup> biennial review of the implementation and operation of the Agreement under Article 7.1 on the basis of a report prepared by the Secretariat (G/LIC/W/49); (v) and continued the discussion regarding improving transparency in notification procedures of the Agreement.

#### 2.1.1 Review of notifications

2.3. Reviewing Members' notifications under various provisions of the Agreement has been one of the main functions of the Committee. During the reporting period, the Committee reviewed 29 notifications submitted by 18 Members under Article 1.4(a) and/or 8.2(b); 41 notifications from 16 Members under Article 5.1-5.4; and 69 Replies to the Annual Questionnaire on Import Licensing Procedures submitted by 40 Members under Article 7.3. The list of notifications submitted by Members during the reporting period is contained in Annexes I to IV.

2.4. It is worth noting that there remain **15** Members who have not submitted any notification under the Agreement since joining the WTO (see Table 1). As emphasized by the Chairperson repeatedly at each formal meeting, Members that have not yet submitted the required notifications are urged to do so without delay. Members who have technical problems in preparing the notifications are requested to seek assistance from the Secretariat.

2.7. Compared with the last review period (2015-2016), this review period witnessed some positive developments on notifications: (1) it is encouraging to see that four Members, namely Botswana, Brunei Darussalam, Kazakhstan and South Africa have submitted their first notifications on import licensing-related laws and regulations under Article 8.2(b) and/or Article 1.4(a); and Gabon submitted its first reply to the annual questionnaire under Article 7.3 of the Agreement. (2) several Members have updated their N/1 notifications and provided more comprehensive information regarding their import-licensing related laws and regulations. (3) an increasing number of developing countries are attaching more importance to transparency and expressed the willingness to complete their notifications with the technical assistance of the Secretariat. In this regard, during the review period, Paraguay, Egypt, the Kingdom of Bahrain, Myanmar have requested national workshops on import licensing and started to prepare/update their notifications seriously.

2.8. In order to improve developing Member officials' understanding of the Agreement and strengthen their capacities to prepare and analyse import licensing notifications, the Secretariat took the initiative of organizing the first Geneva-based Workshop on Import Licensing during 2 to 5 May 2017. Twenty-nine government officials representing twenty-nine developing Members (including LDCs) participated in the four-day workshop. The second Workshop was held from 17 to 20 April 2018 in Geneva and another thirty officials participated. Based on the feedback from the participants, these workshops have been extremely useful to them and have facilitated their preparation of notifications under various provisions of the Agreement. As a concrete result, this review period witnessed several participating Members either submitting their first notification to the Committee, or updating their import licensing-related legislations or replies to the annual questionnaire soon after the workshops.

2.9. On the other hand, it is recognized that increasing the overall level of notification compliance and improving the quality of notifications remains a big challenge for this Committee. For example, in this review period (2017-2018), the total number of Members' replies to the annual questionnaire has decreased from 82 to 69, as compared with that of the last review period (2015-2016). The following Members which had notified under Article 7.3 of the Agreement in the last review period failed to provide any new update for the Year 2017 or Year 2018<sup>3</sup>, namely Brazil, Chile, Colombia, Costa Rica, Haiti, Honduras, Indonesia, Jamaica, Jordan, Korea, the State of Kuwait, Liechtenstein, Mexico, Republic of Moldova, Nepal, Philippines, Saint Vincent and the Grenadines, Trinidad and Tobago, Turkey and Zimbabwe (See Annex VI). How to maintain a relative high level of notification compliance while not adding extra burden to Members remains a question to be discussed.

2.10. At the same time, during its technical assistance and its daily work, the Secretariat has encountered some frequently asked questions raised by delegates which, in its view, deserve clarification and discussion by the Committee. For example, (1) Are administrative measures in names of "import control", "import permit", "import authorization", "import clearance" or "import approval" also import licensing measures? In practice, a few Members had limited themselves to notify only measures in name of "import licensing". (2) Are administrative procedures for issuing technical visas for SPS and TBT purposes, which is a prior condition of importation and involves submission of an application and other documentation to relevant administrative bodies import licensing procedures? Should they also be notified to this Committee? (3) What is the difference between Import Licensing notifications and QR notifications in terms of non-automatic import licensing? Considering that these questions are highly relevant to notification obligations under this Agreement, some discussions in this Committee might be useful before any horizontal solution could be explored between Committees.

### **2.1.2 Discussion of specific trade concerns**

2.11. Another main function of the Committee is to afford Members the opportunity to consult on any matters relating to the operation of this Agreement and to raise specific trade concerns they may have regarding other Members' import licensing regime or administrative practices.

2.12. Following the Rules of Procedures of this Agreement<sup>4</sup>, a total of 14 documents containing written questions on import licensing systems maintained by other Members, and 11 documents containing replies, were circulated in the document G/LIC/Q/- series during the review period. These written questions were addressed to the following Members: Argentina, Bolivia, Brazil, China, Egypt, the European Union, Indonesia, Malaysia, Morocco, the Russian Federation, Thailand, and Viet Nam. The exchanges among Members based on written questions and replies have provided additional clarity regarding the import licensing practices/legislations of the Members. (see Annex V).

2.13. In this regard, a working document titled " Consolidated paper of written questions and replies submitted to the Committee on Import Licensing since 1995" (G/LIC/W/51) has been prepared by

the Secretariat with a view to providing Members with an easy reference to the G/LIC/Q series documents. At the formal meeting held on 22 October 2018, the Committee agreed that the Secretariat would update the document twice a year to include new submissions.

2.14. In addition, following requests from certain Member(s), a number of trade issues have also been included in the agenda of formal meetings during the review period (see Table 4). Some of the issues have been listed in the agenda for years. At the meeting(s), the proponents expressed their views on relevant issues and Members concerned provided oral replies.

### 2.1.3 Review and adoption of the Committee's Annual Report to the Council for Trade in Goods

2.15. In accordance with Article 7.4 of the Agreement, the Committee adopted, on the basis of the documents prepared by the Secretariat (G/LIC/W/48 and G/LIC/W/50), its annual reports to the Council for Trade in Goods. The reports for 2017 and 2018, were adopted and circulated as documents G/L/1187 and G/L/1269, respectively.

### 2.1.4 Twelfth biennial review on the implementation and operation of the Agreement

2.16. Article 7.1 of the Agreement establishes that "the Committee shall review as necessary, but at least once every two years, the implementation and operation of this Agreement, taking into account the objectives thereof, and the rights and obligations contained therein."

2.17. Article 7.2 of the Agreement stipulates that " As a basis for the Committee review, the Secretariat shall prepare a factual report based on information provided under Article 5, responses to the annual questionnaire on import licensing procedures and other relevant reliable information which is available to it. This report shall provide a synopsis of the aforementioned information, in particular indicating any changes or developments during the period of the review, and including any other information as agreed by the Committee."

2.18. At its formal meeting of 22 October 2018, the Committee conducted the 12th biennial review (2017-2018) on the implementation and operation of the Agreement, based on a paper prepared by the Secretariat (G/LIC/W/49). The report was adopted and circulated in document G/LIC/27.

### 2.1.5 Improving transparency in notification procedures of the Agreement

2.19. Ensuring transparency of import licensing procedures applied by WTO Members is one of the main objectives of the Agreement. Taking into account of the complexity of notification obligations under the Agreement and the low compliance rate, discussions have been undertaken by the Committee on how to improve transparency and notification procedures. "Improving transparency in notification procedures of the Agreement – Report by the Chairperson " has been on the agenda of the Committee's formal meeting since 2016.

2.20. At the four formal Committee meetings during the review period, the Chairpersons reported on their consultations on the issue. At these meetings, many Members extended support to the work done by the Chair and the Secretariat so far and expressed willingness to continue the work regarding improving transparency and streamlining notification procedures of the Agreement in the future.<sup>5</sup>

2.21. During the review period, the Committee held two informal meetings. One informal meeting was held under the chairmanship of Mr. Tapio Pyysalo (Finland) on 16 February 2017.<sup>6</sup> The meeting was held to discuss a "comprehensive" notification form prepared by the Secretariat (circulated in room document RD/LIC/10), upon the request of a few Members. Due to strong objections by a few delegations regarding the mandate of the Committee to discuss such a document, the meeting was adjourned without further discussions on the subject.

2.22. An informal meeting was held under the chairmanship of Ms. Lorena Rivera Orjuela (Colombia) on 9 July 2018.<sup>7</sup> The Secretariat introduced the new WTO Import Licensing website/database (<https://importlicensing.wto.org>).<sup>8</sup> The new website/database was developed by the WTO's Market Access Division, with technical support from the Information Technology and Support Division. The objective was to improve transparency, to consolidate all information on import licensing and to provide a more user-friendly platform for Members to obtain specific information otherwise scattered across numerous notifications. The information presented on the website was based on notifications submitted by Members under various provisions of the Agreement. The new "Member profile" gateway on the website provides direct access to import licensing-related laws, regulations and products subject to licensing, as well as administrative procedural details for each category of products for each Member (subject to the availability of notifications), which could significantly enhanced transparency of import licensing measures. At the same meeting, at the request of some Members, the Secretariat made a presentation on the Agreement on Import Licensing Procedures, with a view to familiarizing Geneva-based delegates with the Agreement and its notification requirements.

2.23. At the formal meeting held on 22 October 2018, the US, Japan, the EU, Canada and some other Members supported continuing the discussions on improving notification procedures. The Chairperson expressed her intention to hold informal consultations on related issues in the coming month. In the meantime, the Chair highlighted that the Secretariat had strengthened its technical assistance activities to help developing Members to fulfil their notification obligations. In this regard, two Geneva-based Workshop on Import Licensing had been held with the participation of over 60 officials from 60 developing Members and LDCs. National workshops on the subject had been held in Paraguay and Egypt upon the request of host governments. The Secretariat had also provided a training session on the Agreement to Geneva-based delegates at the informal Committee held on 9 July 2018. These TA activities were highly appreciated by Members and had been effective in bringing in additional notifications.

## 3 CONSULTATION AND DISPUTE SETTLEMENT

3.1. On 19 May 2017, The Russian Federation (document G/LIC/D/52) made a request for consultations on "*Ukraine – measures relating to trade in goods and services*"(DS525), where Articles 1 (inter alia Articles 1.2, 1.3, 1.4(a), 1.5, 1.6); Article 3 (inter alia, Articles 3.2, 3.3,3.4 and

3.5); and Article 5 (inter alia Article 5.1 and 5.2) of the Agreement on Import Licensing Procedures had been cited. The case was in the stage of consultations.

3.2. Regarding "Morocco – Antidumping Measures on Certain Hot-Rolled Steel from Turkey" (DS513), Article 3.2 and 3.3 of the Agreement of Import Licensing Procedures was cited in the request for consultations. The panel was composed on 17 May 2017.

3.3. Regarding "*Indonesia – Measures Concerning the Importation of Bovine Meat*" (DS506), the case was in consultations since 4 April 2016, no dispute panel was established and no withdrawal or mutually agreed solution was notified.

3.4. Regarding "Indonesia – Measures Concerning the Importation of Chicken Meat and Chicken Products." (DS484), the Panel Report was circulated on 17 October 2017. The status report regarding implementation of DSB recommendations was circulated on 23 August 2018.

3.5. Regarding "Indonesia – Importation of Horticulture Products, Animals and Animal Products" (DS478), the Panel Report was circulated on 22 December 2016. The Appellate Body Report was circulated on 9 November 2017. Authorization to retaliate was requested on 15 August 2018.
