AGREEMENT ON IMPORT LICENSING PROCEDURES

NOTIFICATION UNDER ARTICLE 1.4(A)ⁱ AND /OR 8.2(B)ⁱⁱ OF THE AGREEMENT

TAJIKISTAN

The following notification, dated 2 November 2015, is being circulated at the request of the delegation of Tajikistan.

The Government of Tajikistan would like to notify the following legislations to the Committee on Import Licensing of under Article 1.4(a) and /or 8.2(b) of the Agreement:

1. The Resolution of Government of the Republic of Tajikistan № 172 "On approval of provisions on specificities of licensing of separate types of activities (in new edition)" of 3 April 2007

Date of publication: 03 April 2007.

Effective date of requirements: 03 April 2007.

Summary of legislation: This Resolution defines the legal basis of the state policy of the Republic of Tajikistan in the field of pharmaceuticals, medical products and pharmaceutical activity regulates relations arising in connection with the development, manufacturing, preclinical and clinical testing, quality control, efficiency and safety of medicinal products and other relations, arising in this area.

3. The Law of the Republic of Tajikistan on Licensing of Separate Types of Activities №. 37 of 17 May 2007

ⁱ "[...] Publication shall take place, whenever practicable, 21 days prior to the effective date of the requirement but in all events not later than such effective date. Any exception, derogations or changes in or from the rules concerning licensing procedures or the list of products subject to import licensing shall also be published in the same manner and within the same time periods as specified above." See Art. 1.4(a) of the Agreement.
