AGREEMENT ON IMPORT LICENSING PROCEDURES

Licenses are issued according to the decision of the Interministerial Commission concerning the quota allocation.

The Resolution of the Cabinet of Ministers of Ukraine as of 13 March 2013 No. 225 "On amendments to the Resolution of the Cabinet of Ministers of Ukraine No. 1201 of 19 December 2012"

ⁱ "[...] Publication shall take place, whenever practicable, 21 days prior to the effective date of the requirement but in all events not later than such effective date. Any exception, derogations or changes in or from the rules concerning licensing procedures or the list of products subject to import licensing shall also be published in the same manner and within the same time periods as specified above."
