The Resolution of the Cabinet of Ministers of Ukraine of 3 July 2013 № 462 amends the Annex 8 of the Resolution of the Cabinet of Ministers of Ukraine of 19 December 2012 № 1201 (with latest amendments of 13 March 2013) in part where it concerns the quota volume for the following goods:

Coke and semi-coke of coal for the manufacture of electrodes (UKTZED 2704 0011 00)

Other Coke and semi-coke of coal (UKTZED 2704 00 19 00)

Coke and semi-coke of lignite (UKTZED 2704 00 30 00)

Coke and semi-coke of peat, whether or not agglomerated, retort carbon (UKTZED 2704 00 90 00).

UKTZED is the Ukrainian Foreign Economic Activity Commodity Classification, based on Harmonized System 2007.

The mentioned Resolution of 3 July 2013 № 462 establishes quota in volume of 210000 tons for the mentioned above goods (2704 00 11 00, 2704 00 19 00, 2704 00 30 00, 2704 00 9000) instead previously established 0 (zero) tons volume
