14	A summary of the notification in one of the WTO official languages	1. Law No. 15/2019 sets out the legal requirements and rules governing the international trade in rough diamonds in compliance with the Kimberley Process Certification Scheme (KPCS) and domestic laws. Under the Law, operating license is required for business operators engaging in importing, exporting, transiting, buying and selling, and transporting rough diamonds in the Macao SAR. The Law also stipulates a prior authorization for import, export and transit of rough diamonds with obtainment of license and/or Kimberley Process (KP) certificates.
		2. Administrative Regulation No.29/2019 establishes the procedures under which the licenses and the KP Certificates are issued, documents to be submitted for the purpose, validity of the licenses and the KP Certificates, and the customs inspection process.
		3. Chief Executive's Decision No. 141/2019 announces the participating countries and territories of the KPCS.
		4. Chief Executive's Decision No. 142/2019 announces the charge for issuance of KP Certificate of MOP 70.
		5. Secretary for Economy and Finance's Decision No. 70/2019 publishes the formats of the certificate for the KPCS and the Operating License for Rough Diamond Economic Activities for the KPCS.
