## AGREEMENT ON IMPORT LICENSING PROCEDURES

### NOTIFICATION UNDER ARTICLE 5 OF THE AGREEMENT<sup>1</sup>

#### UKRAINE

The following notification, dated 13 May 2013, is being circulated at the request of the delegation of Ukraine.

Interagency Commission for quotas allocation for the goods subject to import licensing in 2013 according to its functions:  1) prepares recommendations on the quotas allocation for goods subject to import licensing in 2013, based on the application and supporting documents submitted by business entities to the Ministry of Economic Development and Trade after the publication on the official website of Ministry of information on the procedure of submission, beginning and final date of applications registration considering the information about entity activities during last three years (imports quantity of coking coal and coking coal, quantity of consumption of Ukrainian domestically produced coking coal, quantities of coke production and coking coal consumption, quantities of production of cast iron, with the use of Pulverized Coal Injection technology in particular);  2) reviews the applications submitted by the Ministry of Economic Development and trade within seven working days after the receipt of applications from business entities;  3) submits to the Ministry of Economic Development and trade elaborated proposals and recommendations.
(h)	<b>Expected duration of the licensing procedure if this can be estimated with some probability, and if not, reason why this information cannot be provided</b>  From 1 June 2013 till 31 December 2013 (including this date).

By this Resolution the date of application of the import licensing procedure was postponed from 27 of April 2013 to 1of June 2013.
