AGREEMENT ON IMPORT LICENSING PROCEDURES

NOTIFICATION UNDER ARTICLE 5 OF THE AGREEMENT¹

UKRAINE

Revision

The following notification, dated 26 July 2013, is being circulated at the request of the delegation of Ukraine.

The Resolution of the Cabinet of Ministers of Ukraine as of 3 July 2013 N° 462 "On amendments to the Annex 8 of the Resolution of the Cabinet of Ministers of Ukraine N° 1201 of 19 December 2012".

The purpose of establishing 210000 tons quota on imports of coke is to stabilize the operation blast furnace production. The quota volume setting is based with consideration of the plans of metallurgical enterprises of Ukraine regarding the transition to Pulverized Coal Injection (fact-PVP) as well as dynamics of coke imports in 2010-2012.

(h) Expected duration of the licensing procedure if this can be estimated with some probability, and if not, reason why this information cannot be provided

Effective from the date of publication till 31 December 2013 (including this date).

The Resolution of the Cabinet of Ministers of Ukraine of 3 July 2013 N° 462 establishes quota in volume of 210000 tons for the mentioned above goods (2704 00 11 00, 2704 00 19 00, 2704 00 30 00, 2704 00 9000) instead of previously established 0 (zero) tons volume (notified under G/LIC/N/2/UKR/3 of 18 April 2013)
