#### AGREEMENT ON IMPORT LICENSING PROCEDURES

### NOTIFICATION UNDER ARTICLES 5.1-5.4 OF THE AGREEMENT

#### UKRAINE

The following notification, dated 27 November 2013, is being circulated at the request of the delegation of Ukraine.

The Resolutions of the Cabinet of Ministers of Ukraine as of 30 October 2013  $N^{\circ}$  791 and  $N^{\circ}$  792 "On amendments to the Annex 8 of the Resolution of the Cabinet of Ministers of Ukraine  $N^{\circ}$  1201 of 19 December 2012".
