**FACTUAL REPORT ON THE STATUS OF RENEGOTIATIONS  
UNDER ARTICLE XXVIII OF THE GATT 1994**

REPORT BY THE SECRETARIAT<sup>1</sup>

*Revision*

**1 INTRODUCTION**

1.1. WTO Members are allowed to modify or withdraw concessions from their schedules through negotiation and agreement with other Members. Article XXVIII of the GATT 1994, entitled "Modification of Schedules", is the main provision dealing with the renegotiation of a tariff concession, which may be initiated under Article XXVIII itself or as a result of Article XXIV:6 procedures.<sup>2</sup> As of the date of this report, Members have initiated or concluded 49 renegotiations since the WTO Agreement entered into force, some of which have been ongoing for a number of years.

1.2. The procedural steps and requirements for undertaking Article XXVIII renegotiations are contained, *inter alia*, in the Interpretative Notes to Article XXVIII, the Guidelines on "Procedures for Negotiations under Article XXVIII"<sup>3</sup>, and the "Understanding on the Interpretation of Article XXVIII of the GATT 1994". Once Article XXVIII procedures are concluded, and in order to introduce the changes to the authentic text of the Schedule, the renegotiating Member must submit, within three months after the action has been completed, a draft with the results of the renegotiation under the 1980 Procedures for Modification and Rectification of Schedules (1980 Procedures).<sup>4</sup>

1.3. At the informal session of the Committee on Market Access that took place on 17 March 2016, the Chairperson drew Members' attention to the status of such renegotiations. She noted that, although some information was being provided by the WTO Secretariat in the annual report entitled "Current Situation of Schedules"<sup>5</sup>, no information was provided on other relevant aspects. This made it difficult for Members to have a comprehensive overview of the status of these renegotiations and may have contributed to the lack of completion of some of these procedures.

1.4. With a view to enhancing transparency and Members' ability to monitor the status of Article XXVIII renegotiations, it was agreed at the informal session of 17 March 2016 that the Secretariat would produce a draft report compiling the relevant information.<sup>6</sup> Members were invited to provide inputs and comments. At its formal meeting of 19 April 2016, the Committee took note of comments made on the draft and agreed that additional comments should be submitted to the Secretariat no later than 3 May 2016. This revised version takes account of all comments received, as well as of subsequent developments up to 12 April 2021.

## 2 CURRENT STATUS OF RENEGOTIATIONS

2.1. The Annex seeks to provide a comprehensive overview of the status of renegotiations under Article XXVIII of the GATT 1994. It consists of a table with the following columns:

- Column 1:** Indicates the item number in the table.
- Column 2:** Lists the WTO Members which have requested to initiate procedures under Article XXVIII of the GATT 1994 since the WTO Agreement entered into force on 1 January 1995, as well as procedures that were initiated prior to that date, under the GATT 1947, and concluded under the WTO.<sup>7</sup> The table is sorted in alphabetical order, in accordance with document WT/INF/43/Rev.22.
- Column 3:** Lists the specific paragraph of Article XXVIII that was invoked by the Member initiating the procedures (i.e. paragraphs 1 or 5) or requesting authorization to initiate (paragraph. 4), as well as those cases where Article XXIV:6 or other procedures have been invoked by the Member concerned.
- Column 4:** Provides an indication of the types of products covered by the request, as well as the approximate number of national tariff lines. As the calculation is based on the information provided in the notifications, which is typically at the national tariff line level, the data is not standardized. This means that the figures are not comparable across notifications.
- Column 5:** Indicates the number of Members that have submitted a claim of interest in the concessions subject to renegotiation and is based on the Secretariat's records. Paragraph 4 of the Guidelines on "Procedures for Negotiations under Article XXVIII" provides that Members considering themselves to have "principal" or a "substantial supplying" interest in a concession that is the subject of negotiation and consultation should communicate their claim in writing to the initiating Member and, at the same time, inform the Secretariat. Although Members holding "initial negotiating rights" are not required to submit a claim, in practice, they have occasionally done so. The column reflects the total number of communications in the Secretariat's record.
- Column 6:** Provides information on the conclusion of bilateral negotiations and consultations under Article XXVIII, including the submission of joint letters and final reports to the Secretariat. The "Procedures for Negotiations under Article XXVIII" provide that the Member following the procedures should submit to the Secretariat: (i) a report and a joint letter upon completion of each bilateral negotiation and (ii) a final report upon completion of all its bilateral negotiations.
- Column 7:** Provides information on the draft changes that have been submitted pursuant to the 1980 Procedures. Paragraph 1 provides *inter alia* that changes in the authentic texts of Schedules resulting from action under Article XXVIII shall be certified by means of Certifications. To initiate this final step of the procedures, a draft of such changes shall be communicated to the Director-General within three months after the action has been completed. The column provides information on the draft modifications submitted pursuant to these procedures<sup>8</sup>, as well as the relevant certification by the Director-General<sup>9</sup>, if any.
- Column 8:** Indicates the latest status known to the WTO Secretariat.
