**Committee on Market Access**

**DERESTRICTION OF THE URUGUAY ROUND NEGOTIATING MATERIALS**

[DRAFT] DECISION

The General Council,

*Having regard to* Articles IV:2 and IX:1 of the WTO Agreement;

*Having regard to* the agreement of 8 December 1994 between the GATT CONTRACTING PARTIES, the Preparatory Committee for the WTO and the Interim Commission for the International Trade Organization (ICITO), approved by the WTO General Council on 31 January 1995 (WT/L/36), providing *inter alia* for the transfer of assets and records of the GATT to the WTO;

*Considering that*, in the interest of a better access of the general public to the historical negotiating documentation of the GATT 1947 multilateral trade negotiations, a general derestriction of such documentation is in order;

*Noting that* the derestriction of the majority of the historical bilateral negotiating documentation pertaining to the first seven GATT 1947 Tariff Conferences has already taken place<sup>1</sup>;

*Noting that* the Committee on Market Access has approved<sup>2</sup> the derestriction of the negotiating materials of the Uruguay Round which are listed in the annex;

*Decides as follows:*

The historical bilateral negotiating documentation of the Uruguay Round listed in the annex to this document shall be derestricted as of the date of this Decision.
