**STATUS OF NOTIFICATIONS UNDER THE DECISION ON NOTIFICATION  
PROCEDURES FOR QUANTITATIVE RESTRICTIONS (G/L/59/REV.1)**

REPORT BY THE SECRETARIAT<sup>1</sup>

1. The Decision on Notification Procedures for Quantitative Restrictions<sup>2</sup> provides that "Members shall make complete notifications of all quantitative restrictions in force by 30 September 2012 and at two yearly intervals thereafter. They should also notify changes to those quantitative restrictions as soon as possible, but not later than six months from their entry into force".<sup>3</sup> This report has been prepared by the Secretariat pursuant to paragraph 7 of the Decision.<sup>4</sup>

2. As of 4 October 2021, a total of 58 Members<sup>5</sup> have submitted at least one notification of QRs in force. For each biennial period, the following notifications<sup>6</sup> have been received:

**2012-2014:** 29 notifications from 23 Members.

**2014-2016:** 33 notifications from 30 Members.

**2016-2018:** 31 notifications from 31 Members.

**2018-2020:** 87 notifications from 49 Members.

**2020-2022:** 63 notifications from 39 Members.

3. The complete list of notifications received by the Secretariat is provided in the Annex. This version of the report provides additional information in terms of the date of submission and circulation of the documents, as well as the language of the annex of the information in Section 1 of the notification, which is not translated.
