According to the Resolution of the Cabinet of Ministers of Ukraine of 26 July 2022 No. 832 "On Amending Annexes 1 and 5 of the Resolution of the Cabinet of Ministers of Ukraine of No. 1424 of 29 December 2021" Ukraine lifted export restrictions of rye (HS 1002), mineral or chemical fertilizers (nitrogenous, phosphatic, potassic), mineral or chemical fertilizers containing two or four of the fertilizing elements nitrogen, phosphorus and potassium, other fertilizers, goods of this Chapter in tablets or similar forms or in packages of a gross weight not exceeding 10 kg (HS 3102, 3103, 3104, 3105).

These goods are now subject to automatic licensing. Effective 28 July 2022.
