NOTIFICATION UNDER ARTICLE 5 AND PARAGRAPH 4 OF ANNEX II TO THE AGREEMENT ON RULES OF ORIGIN

A. NON-PREFERENTIAL RULES OF ORIGIN

1. Article 5.1 of the Agreement on Rules of Origin envisages that each Member shall provide to the Secretariat, within 90 days after the date entry in to force of the WTO Agreement for it, its rules of origin, judicial decisions and administrative rulings of general application relating to rules of origin in effect on that date. If by inadvertence a rule of origin has not been provided, the Member concerned shall provide it immediately after this fact becomes known. Lists of information received and available within the Secretariat shall be circulated to the Members by the Secretariat.

2. Article 5.2 of the Agreement on Rules of Origin provides that during the period referred to in Article 2, Members introducing modifications, other than *de minimis* modifications, to their rules of origin or introducing new rules of origin, which, for the purpose of the Article, shall include any rule of origin referred to in paragraph 1 and not provided to the Secretariat, shall publish a notice to that effect at least 60 days before the entry into force of the modified or new rule in such a manner as to enable interested parties to become acquainted with the intention to modify a rule of origin or to introduce a new rule of origin, unless exceptional circumstances arise or threaten to arise for a Member. In these exceptional cases, the Member shall publish the modified or new rule as soon as possible.

Ghana does not have any non-preferential rules of origin.

B. PREFERENTIAL RULES OF ORIGIN

1. Paragraph 4 of Annex II of the Agreement on Rules of Origin envisages that Members shall provide to the Secretariat promptly their preferential rules of origin, including a listing of the preferential arrangements to which they apply, judicial decisions, and administrative rulings of general application relating to their preferential rules of origin in effect on the date of entry into force of the WTO Agreement for the Member concerned. Members shall provide any modifications to their preferential rules of origin as soon as possible to the Secretariat. Lists of information received and available within the Secretariat shall be circulated to Members by the Secretariat.

GHANA

(Notification in English)

The following preferential rules of origin are maintained by Ghana under the ECOWAS Trade Liberalization Scheme:

- i) they have been wholly produced from raw materials of Community origin, used alone or mixed with other materials, provided that they represent at least 60% of the total raw materials used;
- ii) they are not wholly produced in Member States and where their production requires the exclusive use of materials which are to be classified under a different tariff sub-heading from that of the product;
- iii) they are not wholly produced in Member States and where their production requires the use of materials which have received a value-added of at least 30% of the ex-factory price of the finished goods.
