## NOTIFICATIONS ON FISHERIES AND AQUACULTURE SUBSIDIES 2016, 2017, 2018<sup>1</sup>

## **Background**

In order to facilitate understanding of the programmes mentioned by Colombia in notifications on fisheries subsidies, it is important to note that the National Fishing and Aquaculture Authority (AUNAP), an entity attached to the Ministry of Agriculture and Rural Development, is responsible for exercising authority over fisheries and aquaculture in Colombia. As part of its policy of promotion and sustainable development of these resources, it develops processes for the planning, research, management, promotion, regulation, registration, reporting, inspection, surveillance and control of nationwide fisheries and aquaculture activities.

AUNAP receives funds from the national general budget to carry out these activities, which enables it to develop programmes that will be of general benefit to the Colombian fisheries and aquaculture sector through the following investment projects.

## 1. Updating and implementation of domestic measures for fisheries and aquaculture management and development

The aim of this programme is the efficient management of the country's fisheries and aquaculture sector, taking account of sectoral and domestic needs and legal frameworks, and the promotion of activities geared towards the productive, competitive and sustainable development of aquaculture and artisanal fisheries.

## 2. Development of domestic inspection and surveillance activities for fisheries and aquaculture resources

The aim is to provide training to persons who rely on fishing as an economic activity, on the current regulations and management measures established for the country's fisheries and aquaculture resources. In rolling out the programme, AUNAP:

- Establishes and implements efficient monitoring and control mechanisms within Colombia to combat illegal, unreported and unregulated (IUU) fishing;
- Sets and applies sanctions for infringements of regulations in order to ensure better domestic compliance;
- Updates databases of landed fishery production to inform the development of relevant management measures.

## 3. Knowledge development to ensure the efficient and sustainable domestic use of fisheries and aquaculture resources

The aim is to generate information for decision-making as part of the framework for the sustainable development of fisheries and aquaculture in the country, through:

 Research aimed at identifying and quantifying fisheries resources, and research seeking to improve technological processes at the stages of extraction, cultivation, processing and placement on the market.

## I. UPDATING AND IMPLEMENTATION OF DOMESTIC MEASURES FOR FISHERIES AND AQUACULTURE MANAGEMENT AND DEVELOPMENT

#### 1. Programme description:

The aim is the efficient management of the country's fisheries and aquaculture sector, taking account of sectoral and domestic needs and legal frameworks, and the promotion of activities geared towards the productive, competitive and sustainable development of aquaculture and artisanal fisheries. This involves:

- In each of the AUNAP regions, providing training for persons engaged in fishing and aquaculture on the rules and procedures for such activities;
- Processing registrations, the granting of fishing permits, authorizations or patents, and changes to or cancellations of permits;
- Producing fingerlings in AUNAP stations and centres to support fish-breeding and restocking programmes;
- Improving fisheries management processes;
- Promoting inter-institutional agreements with public or private entities or other organizations in order to create collaborative spaces that will lead to technical and logistical efforts being combined in the management of the fisheries and aguaculture sector.

The programme specifically aims to transform artisanal fisheries into a sustainable sector. Steps taken as part of this programme to promote artisanal fisheries were aimed at strengthening the coastal marine and inland fisheries sector, with the provision of equipment, inputs or elements, such as outboard motors, boats, best-practice kits for fish-handling, freezers, scales and fishing gear.

To establish, update and implement management and promotion measures that lead to the sustainable domestic use of fisheries and aquaculture resources, taking account of sectoral and domestic needs and legal frameworks, and the promotion of activities geared towards the productive, competitive and sustainable development of aquaculture and artisanal fisheries.

### 4. Background and authority for the support

## II. DEVELOPMENT OF DOMESTIC INSPECTION AND SURVEILLANCE ACTIVITIES FOR FISHERIES AND AQUACULTURE RESOURCES

#### 1. Programme description:

This programme seeks to increase sector stakeholders' knowledge of fishery activity regulations that foster a well-managed, sustainable use of fisheries and aquaculture resources. This involves:

- Establishing efficient mechanisms for the control of illegal, unreported and unregulated (IUU) fishing, in compliance with the FAO International Plan of Action and in cooperation with the General Maritime Directorate of Colombia (in charge of the Port State), the aim being to prevent, deter and eliminate such practices;
- The programme includes the imposition of sanctions for failure to comply with domestic and international standards promoting the sustainable use of resources.

The programme focuses on implementing the following components:

Raising public awareness of regulations and measures for managing the country's fisheries and aquaculture resources. Efforts have been made to raise awareness and disseminate current management, administrative and control measures, with a view to strengthening the control and surveillance system at governance level.

**Establishing efficient monitoring and control mechanisms within Colombia to combat illegal, unreported and unregulated (IUU) fishing.** Provision has been made for inspection and surveillance operations, the publication of a general fisheries register on the AUNAP website, and the dissemination, in the regions, of mechanisms for formally lodging complaints regarding illegal fishing, such as, for example, the early warning system in the exclusive fishing zone for artisanal fisheries in northern Chocó.

**Setting and applying sanctions for infringements of regulations in order to ensure better domestic compliance.** Following inspection and surveillance operations, administrative investigations are opened where necessary.

**Updating databases of landed fishery production to facilitate the development of domestic management measures.** The aim is to complement the information generation process and comply with core objectives relating to the strengthening of the country's fisheries and aquaculture statistics (collection, analysis and systemization of data on catch and landing, maturity stages, fishing gear and aquaculture production) and their inclusion in the Colombian Statistical Fisheries Service (SEPEC) platform.

## 3. Policy objective and/or purpose of the support

The aim of the programme is to ensure that sector stakeholders effectively implement domestic measures for the management of fisheries and aquaculture resources.

To achieve this, training on current regulations and measures established for the management of the country's fisheries and aquaculture resources is provided to persons who rely on fishing as an economic activity.

## 4. Background and legislation for the support

Domestic regulatory framework:

- National Development Plan governing each four-year government period and establishing policy guidelines for developing the country's fishery and aquaculture activities.
- Law No. 13 of 1990 General Law on the Fisheries Sector and its Regulatory Decree No. 2256 of 1991.

Decree No. 4181 of 2011 establishing AUNAP.

## International guidelines:

- Code of Conduct for Responsible Fisheries, Convention on Biological Diversity, and United Nations Convention on the Law of the Sea. The latter is used for reference purposes by Colombia, as it is not binding and its application is voluntary.

## III. KNOWLEDGE DEVELOPMENT TO ENSURE THE EFFICIENT AND SUSTAINABLE DOMESTIC USE OF FISHERIES AND AQUACULTURE RESOURCES

## 1. Programme description:

The programme aims to contribute to the sustained development of the fisheries and aquaculture sector, ensuring the rational use of exploited resources, which requires conducting research to identify and quantify such resources.

The programme is designed as a strategic tool to fill the existing information gaps on the population and ecosystem dynamics of the fisheries resources that are currently being exploited in marine and inland areas.

This calls for appropriate intervention by AUNAP, from the planning through to the execution stage. A foundation of scientific evidence must be built to ensure that any decisions made benefit the user communities, institutions and authorities involved, without neglecting the pursuit of economic, environmental, social, cultural and biological sustainability of resources. This involves:

- Developing production management programmes, strengthening monitoring measures, assessing the impact of fishing gear and methods used, and analysing the shark production chain and the impact of the ZEPA exclusive fishing zone for artisanal fisheries on the conservation of fisheries resources;
- Fisheries and socioeconomic profiling for the purposes of fisheries management;
- Assessing the impact of fishing gear and methods used in the Magdalena Medio region, Magdalena River Basin and Orinoco Basin, with a view to updating regulations, given current fishery dynamics;
- Research into demersal marine resources, generating information on the biological characteristics of these fishery resources for use as a tool in managing them in marine waters under Colombian jurisdiction;
- Biological monitoring, in ports and fishing zones and on board vessels, of fishery resources in the main industrial and artisanal marine fisheries of the Pacific coast and the Caribbean, and in the inland areas of the Magdalena-Cauca, Sinú, Atrato, Catatumbo, Orinoco and Amazonian river basins in Colombia:
- Research into native and exotic species in marine and inland aquaculture and development of new production technologies;
- Conducting a risk and vulnerability assessment of elasmobranchs and analysing the shark production chain and the impact of the ZEPA exclusive fishing zone for artisanal fisheries on the conservation of fisheries resources.
