1 INNOVATION FUNDING

1.1 SUPPORT TO INNOVATION FUNDING

1. <u>Title of the subsidy programme</u>

Scheme for support of innovative undertakings through the National Innovation Fund.

2. Period covered by the notification

2015; 2016

3. Policy objective and/or purpose of the subsidy

The scheme provides support for research and development activities of the enterprises working in collaboration with research organizations.

- 4. <u>Background and authority for the subsidy (incl. identification of the legislation under which it is granted)</u>
- Council of Ministers' Decision No. 723 of 8 September 2004 for Adoption of Innovation Strategy of the Republic of Bulgaria and Measures for its Implementation, as amended by Council of Ministers' Decision No. 385 of 22 May 2006;
- Council of Ministers' Decree No. 15 of 31 January 2005 for Providing Funds from 2005 State Budget to the Ministry of Economy for the Establishment of National Innovation Fund (NIF);
- NIF Management Rules and Guidance on Application for Funding of Innovative Enterprises, approved by Order No. RD-16-82/2005, Order No. RD-16-464/2005 and Order No. RD-16-1402/2006, issued by the Minister of Economy (with amendments).

Authority responsible for the subsidy: Small and Medium Enterprises Promotion Agency at the Ministry of Economy.

5. Form of the subsidy

Grant.

6. To whom and how the subsidy is provided

The grant is provided to innovative enterprises from all sectors and regions, research institutes, organizations and universities for support of research activities.

7. <u>Subsidy per unit or in case where it is not possible, the total amount or the annual budgeted for that subsidy</u>

In 2015 - payments effectuated at the amount of BGN 6.424 million. In 2016 - payments effectuated at the amount of BGN 4.392 million.

8. <u>Duration of a subsidy and/or any other time limits attached to it</u>

For the period of 2009-2013, and a prolongation till 30 June 2014, based on the General Block Exemption Regulation (GBER) 800/2008 prolongation with Regulation 1224/2013. The same rules apply to payments in 2015 and 2016.

The grant is provided to enterprises and organizations for research and dissemination of knowledge from all sectors and regions.

8. Duration of a subsidy and/or any other time limits attached to it

For the period of 2016 - 2020, based on GBER 651/2014 (SA.46353).

2 ASSISTANCE TO ECONOMIC DEVELOPMENT AND STRUCTURAL ADJUSTMENT

2.1 SUPPORT TO REGIONAL DEVELOPMENT

1. <u>Title of the subsidy programme</u>

Corporate Tax Exemption Scheme for tax relief constituting regional aid in accordance with Article 184 (linked to Art. 189) of the Corporate Income Tax Act (CITA).

2. Period covered by the notification

2015; 2016

3. Policy objective and/or purpose of the subsidy

Regional aid for initial investment and job creation linked to the investment.

- 4. <u>Background and authority for the subsidy (incl. identification of the legislation under which it is granted)</u>
- Corporate Income Taxation Act (CITA), promulgated, State Gazette (SG) No. 105 of 22 December 2006, as last amended and supplemented, SG No..97 of 6 December 2016.

In accordance with Article 189 of the CITA the taxable persons must fulfill specified conditions in order to receive regional aid related to the initial investment in municipalities with rate of unemployment for the year of retention 25% or higher than the national average for the same period.

Authority responsible for the subsidy: National Revenue Agency at the Ministry of Finance.

5. Form of the subsidy

Tax relief

6. To whom and how the subsidy is provided

Any taxable person fulfilling the conditions specified under Article 184 (linked to Art. 189) of CITA can retain corporate tax and is obliged to invest it in material and immaterial assets as a part of his initial investment. The initial investment has to be made in municipalities where the rate of unemployment for the year of retention is 25% or higher than the national average for the same period. The activity related to the initial investment shall be implemented in the respective municipality for at least 5 years after the year of completion of the initial investment and this circumstance is to be declared annually by the annual tax returns until the lapse of the five-year period.

7. <u>Subsidy per unit or in case where it is not possible, the total amount or the annual budgeted</u> for that subsidy

In 2015 - BGN 9.758 million In 2016 - BGN 6.747 million

8. Duration of a subsidy and/or any other time limits attached to it

6. To whom and how the subsidy is provided

The beneficiaries are SMEs and large companies. The subsidy covers the implementation and maintaining of investment projects of national importance (priority investment projects). Projects must meet the minimum requirements regarding the amount of investment and employment to be created, as stated in the Rules for Implementation of the Investment Promotion Act.

Priority investment projects under the measure can be promoted with the provision of grants:

- up to 50% of the cost for investment in education and scientific research;
- up to 10% of the cost for investment in the processing industry.

5 FILM INDUSTRY SUPPORT

1. <u>Title of the subsidy</u>

Bulgarian Film Industry support

2. <u>Period covered by the notification</u>

2015; 2016

3. Policy objective and/or purpose of the subsidy

The aid is aimed at supporting the development and preservation of the Bulgarian film culture. The main priorities are the following: assistance in the production and distribution of films of high artistic merit and debut film projects; ensuring the right of public access to various forms of film-related creative work; protection of the rights and interests of audience; support to new talent and young writers; domestic and international promotion of Bulgarian films.

- 4. <u>Background and authority for the subsidy (incl. identification of the legislation under which it is granted)</u>
- Law on Film Industry promulgated, SG No. 105 of 2 December 2003, as last amended and supplemented, SG No. 95 of 29 November 2016;
- Rules of Procedure of the National Film Centre Executive Agency;
- Protection and Development of Culture Act promulgated, SG No. 50 of 1 June 1999, as last amended and supplemented, SG No. 16 of 26 February 2016;
- 2015 or 2016 State Budget of the Republic of Bulgaria Act;
- Council of Ministers' Decree No 24 of 16 January 2015 on the Implementation of the 2015 State Budget of the Republic of Bulgaria, promulgated, SG No. 107 of 24 December 2014;

The beneficiaries are film production, distribution and promotion companies. Support may be provided to Bulgarian films associated with national displays and commemorations of events and notable historical figures, as well as debut films. The aid is not reserved exclusively for nationals and is provided regardless of the beneficiary's nationality or place of residence.

7. <u>Subsidy per unit, or in case where it is not possible, the total amount or the annual budgeted for that subsidy</u>

In 2015 – BGN 13.457 million; In 2016 – BGN 13.2 million.

1. <u>Title of the subsidy</u>

Support to energy-intensive users in the form of a reduced surcharge

2. <u>Period covered by the notification</u>

2015; 2016

3. Policy objective and/or purpose of the subsidy

Support to compensate energy intensive users (EIUs) for part of the surcharge to finance the support for renewable electricity.

- 4. <u>Background and authority for the subsidy (incl. identification of the legislation under which it is granted)</u>
- Ordinance on Reducing the Burden Related to the Cost of Energy from Renewable Energy Sources, No E-RD-04-06 of 28.09.2016;
- Energy Law, promulgated, SG No. 107 of 9 December 2003, as last amended and supplemented, SG No. 51 of 27 June 2017;

- Guidelines on State Aid for Environmental Protection and Energy 2014-2020, OJ C 200, 28.6.2014 (EEAG).

Granting authority: Ministry of Energy. The aid measure is financed from the Electricity System Security Fund (the Fund). The establishment of the Fund is decreed by special provisions – Article 366 of the Energy Law.

5. Form of the subsidy

6. To whom and how the subsidy is provided

The beneficiaries of the notified scheme are industrial companies that are active¹ in a sector listed in Annex 3 of the EEAG and industrial companies with an electro-intensity of at least 20% that are active in a sector listed in Annex 5 of the EEAG.

The primary objective is environmental protection through promotion of energy production from renewable energy sources.
