NEW AND FULL NOTIFICATION PURSUANT TO ARTICLE XVI:1 OF THE GATT 1994 AND ARTICLE 25 OF THE AGREEMENT ON SUBSIDIES AND COUNTERVAILING MEASURES

RUSSIAN FEDERATION

The following communication, dated 27 December 2019, is being circulated at the request of the Delegation of the Russian Federation.

Attached is the 2017-2018 new and full notification of the Russian Federation pursuant to Article XVI:1 of the GATT 1994 and Article 25 of the Agreement on Subsidies and Countervailing Measures (SCM Agreement). In accordance with Article 25.7 of the SCM Agreement, this notification does not prejudge, under the GATT 1994 and the SCM Agreement the legal status of the notified programs, their effects, or the nature of the programs themselves.

Information on programs granted or maintained on the sub-federal level of the Russian Federation is included in the Annex.
