# NOTIFICATION UNDER ARTICLE 12.1(A) OF THE AGREEMENT ON SAFEGUARDS ON INITIATION OF AN INVESTIGATION AND THE REASONS FOR IT

TÜRKIYE

#### Ethyl Acetate

The following communication, dated and received on 8 April 2024, is being circulated at the request of the delegation of Türkiye.

Republic of Türkiye hereby notifies the Committee on Safeguards, pursuant to Article 12.1(a) of the Agreement on Safeguards on initiation of a safeguard investigation on imports of ethyl acetate.

#### 1. The date when the investigation was initiated

The investigation was initiated on 6 April 2024. The related Communiqué was published in the Official Gazette on the same date.

#### 2. The product subject to the investigation

The product under investigation is hereinafter referred to as "ethyl acetate". Ethyl acetate is currently classified in the Turkish Customs Tariff Schedule under the customs tariff code of 2915.31.00.00.00.

## 3. The reasons for the initiation of investigation

The investigation was initiated upon an evaluation of a safeguard petition from the domestic industry and on the basis of the evidence and the information contained therein.

The information currently available indicates that there is an absolute and relative increase in imports of ethyl acetate and the economic indicators of the applicant companies such as production, domestic sales, capacity utilization rates and profitability have significantly deteriorated.
