NOTIFICATION UNDER ARTICLE 12.1(A) OF THE AGREEMENT ON SAFEGUARDS ON INITIATION OF AN INVESTIGATION AND THE REASONS FOR IT

NOTIFICATION UNDER ARTICLE 12.4 OF THE AGREEMENT ON SAFEGUARDS

(Flat- rolled products of iron, non - alloy steel, trailers and semi - trailers)

The following communication, dated 5 October 2015, is being circulated at the request of the Delegation of the Republic of Zambia.

The Republic of Zambia hereby submits to the Committee on Safeguards the following notifications:

- a. Initiation of an investigation procedure with a view to the application of a safeguard measure to imports of flat rolled products of iron, non alloy steel and trailers; and
- b. Imposition of a provisional safeguard measure.

1 PROVISIONAL SAFEGUARD MEASURES

The safeguard measure is provisional in nature and will last for 180 days from 10 July 2015 to 10 January 2016.

2 DATE OF INITIATION OF INVESTIGATIONS

The investigations were initiated on 10 July 2015.

3 PERIOD OF INVESTIGATIONS

The period of investigation is 10 July 2015 to 10 January 2016.

4 PRODUCTS UNDER INVESTIGATIONS

5 REASONS FOR INITIATIATION OF INVESTIGATIONS

The investigation were initiated following the examination of safeguard petition of the Domestic Industry alleging serious injury and threat thereof caused by increased imports of the aforesaid goods into the Republic of Zambia. Relevant factors having significant bearing on the present deteriorating domestic industry include the following:

- a. The import of the aforesaid goods has shown increasing trend in absolute terms as well as the relative terms;
- b. Capacity utilisation of the domestic industry has declined in the most recent period;
- c. Share of domestic industry in domestic consumption and domestic demand has fallen significantly; and
- d. Profitability of domestic industry has steeply deteriorated, leading to financial losses.
