Pursuant to Article 12 and Article 9 of the WTO Agreement on Safeguards, the Philippines hereby notifies the Committee on Safeguards of the amendment to its safeguards notification made in G/SG/N/8/PHL/11/Suppl.2 - G/SG/N/10/PHL/9/Suppl.1/ - G/SG/N/11/PHL/11/Suppl.2 dated 24 November 2020 regarding the definitive safeguard measure on the importation of cement from various countries.
