6.	<b>Description of content:</b> This Order of the Minister of Agriculture, Rural Development and Water Management provides some protective measures against the outbreak of foot and mouth disease in the Sadong Region, P'YONGYANG-SI, Republic of Korea. Stopping the import of all live animals (domestic and wild) like cattle, pigs, sheep and goats, from the territory of the Sadong Region, P'YONGYANG-SI, Republic of Korea to the Albanian territory; stopping the import of meat and products of the above-mentioned animals and milk from the territory of the Sadong Region, P'YONGYANG-SI, Republic of Korea to the Albanian territory. The veterinary certificate should guarantee their origin. The measures also consist in stopping the import of animal feeding products that contain products from animal origin; stopping the import of unsterile biological materials from the territory of the Sadong Region, P'YONGYANG-SI, Republic of Korea to the Albanian territory.
