The following communication, received on 20 January 2015, is being circulated at the request of the Delegation of the United Arab Emirates.

GCC Guide for Control on Imported Foods

This Guide describes principles and regulatory requirements to be applied by the exporting country and the importing GCC countries in assuring the safety and suitability of shipments of imported food. Health certificates for imported food (from animal and plant origins) which include specific attestations are provided in the Guide.

In 2011, United Arab Emirates notified WTO (SPS) about this Guide (G/SPS/N/ARE/22). Due to comments from many WTO Members, this Guide had been reviewed by GCC Food Safety Committee and modified accordingly. The attached version has been adopted by all GCC countries, and the proposed date of entry into force is 1st June 2015.
