This is following the immediate notification to the World Organization for Animal Health (OIE) regarding Highly Pathogenic Avian Influenza Virus (HPAI) outbreaks which have occurred in Landes, Haute-Vienne, Aveyron and Gers provinces in France.

This is following the immediate notification to the World Organization for Animal Health (OIE) regarding Highly Pathogenic Avian Influenza Virus (HPAI) outbreaks which have occurred in these provinces in France, in compliance with Article 10.4.4, Chapter 10.4 of the World Organization for Animal Health (OIE) Terrestrial Animal Health Code.
