<b>5.</b>	<b>Title of the notified document:</b> United Arab Emirates is imposing a temporary ban on the importation of domestic and wild birds and their untreated by-product, day-old chicks, hatching eggs from Sweden, and imposition of a temporary ban on poultry meat and table eggs from Skane, province in Sweden. <b>Language(s):</b> Arabic. <b>Number of pages:</b> 2
<b>6.</b>	<b>Description of content:</b> Following the notification published by the World Organization for Animal Health (OIE) on 25 November 2016 regarding the outbreak of Highly Pathogenic Avian Influenza Virus (HPAI) in Skane, Sweden, United Arab Emirates is applying a precautionary sanitary measure to prevent the risk of introducing HPAI virus through the imports of live birds and their products from Sweden. These measures include:  <ol style="list-style-type: none"> <li>1. Temporary ban on the importation of domestic and wild birds and their untreated by-products, day-old chicks and hatching eggs originating from Sweden;</li> <li>2. Temporary ban on poultry meat and table eggs and their untreated products from Skane, province in Sweden, except heat-treated products;</li> <li>3. Consignments of poultry meat shipped from Skane, Sweden, before 3 November 2016 were permitted.</li> </ol>

<b>8.</b>	<b>Nature of the urgent problem(s) and reason for urgent action:</b> There is a risk of contamination from importing poultry and poultry products from Skane, Sweden, which is affected with Highly Pathogenic Avian Influenza. This follows the notification of Highly Pathogenic Avian Influenza in Skane, Sweden on 25 November 2016. These applied measures are in compliance with Article 10.4.4, Chapter 10.4 of the World Organization for Animal Health (OIE) Terrestrial Animal Health Code.
