#### Phytosanitary import requirements for Strawberries seedlings (*Fragaria ananassa*) from Spain

This is to notify that the Secretariat of Animal and Plant Health and Inspection - SDA from the Ministry of Agriculture, Livestock and Food Supply - MAPA issued Normative Instruction No. 23 on 9 October 2015, published in the "Diário Oficial da União" (Federal Official Journal) from 13 October 2015, section 1, page 6, to approve the phytosanitary import requirements for strawberry seedlings (*Fragaria ananassa*) from Spain, notified as a draft on G/SPS/N/BRA/375 on 27 April 2011.
