The following communication, received on 7 July 2016, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Imazapyr

The proposed maximum residue limit (PMRL) document for imazapyr notified in G/SPS/N/CAN/1002 (dated 1 April 2016) was adopted 27 June 2016. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm) Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.3 Kidney of cattle, goats, horses, and sheep¹

ppm = parts per million

The 0.05 ppm MRL currently established for meat byproducts of cattle, goats, horses and sheep will be revised to exclude kidney to accommodate the distinct kidney MRL. The 0.05 ppm MRL established for hog meat by-products remains unchanged.
