Established Maximum Residue Limit: Benoxacor

The proposed maximum residue limit (PMRL) document for benoxacor notified in G/SPS/N/CAN/1049 (dated 10 August 2016) was adopted 6 November 2016. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm) Raw Agricultural Commodity (RAC) and/or Processed Commodity

O.01 African eggplants; cucurbit vegetables (Crop Group 9); leaf petioles vegetables (Crop Subgroup 22B); edible-podded soybeans; eggplants; oriental radish roots; oriental radish tops; parsnip roots; pea eggplants; scarlet eggplants
