#### Addendum

The following communication, received on 30 August 2017, is being circulated at the request of the Delegation of <u>Canada</u>.

#### Established Maximum Residue Limit: Azamethiphos

The proposed maximum residue limit (PMRL) document for azamethiphos notified in G/SPS/N/CAN/1056 (dated 23 September 2016) was adopted 15 August 2017. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm) Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.05 Fish

ppm = parts per million
