#### Addendum

The following communication, received on 10 February 2017, is being circulated at the request of the Delegation of <u>Canada</u>.

### Established Maximum Residue Limit: Spinetoram

The proposed maximum residue limit (PMRL) document for spinetoram notified in G/SPS/N/CAN/1073 (dated 11 November 2016) was adopted 6 February 2017. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:
