Established Maximum Residue Limit: Spirotetramat

The proposed maximum residue limit (PMRL) document for spirotetramat notified in G/SPS/N/CAN/1074 (dated 11 November 2016) was adopted 6 February 2017. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:
