The following communication, received on 8 June 2017, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Prothioconazole

The proposed maximum residue limit (PMRL) document for prothioconazole notified in G/SPS/N/CAN/1095 (dated 7 March 2017) was adopted 1 June 2017. The proposed MRL was established via entry into the Maximum Residue Limit Database and is provided directly below:

MRL (ppm) Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.4 Undelinted cotton seeds

ppm = parts per million

MRLs established in Canada may be found using Health Canada's *Maximum Residue Limit Database* (http://pr-rp.hc-sc.gc.ca/mrl-lrm/index-eng.php) on the *Maximum Residue Limits for Pesticides* webpage (http://www.hc-sc.gc.ca/cps-spc/pest/part/protect-proteger/food-nourriture/mrl-lmr-eng.php). The database allows users to search for pesticides(s) or for food commodity(ies).
