### Addendum

The following communication, received on 8 June 2017, is being circulated at the request of the Delegation of Canada.

#### Established Maximum Residue Limit: Prothioconazole

The proposed maximum residue limit (PMRL) document for prothioconazole notified in G/SPS/N/CAN/1095 (dated 7 March 2017) was adopted 1 June 2017. The proposed MRL was established via entry into the Maximum Residue Limit Database and is provided directly below:

MRL (ppm)    Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.4            Undelinted cotton seeds

ppm = parts per million

MRLs established in Canada may be found using Health Canada's *Maximum Residue Limit Database* (<http://pr-rp.hc-sc.gc.ca/mrl-lrm/index-eng.php>) on the *Maximum Residue Limits for Pesticides* webpage (<http://www.hc-sc.gc.ca/cps-spc/pest/part/protect-proteger/food-nourriture/mrl-lmr-eng.php>).
