The following communication, received on 30 August 2017, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Dodine

The proposed maximum residue limit (PMRL) document for dodine notified in G/SPS/N/CAN/1119 (dated 7 June 2017) was adopted 22 August 2017. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm) Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.5 Bananas

ppm = parts per million
