Established Maximum Residue Limit: Ethylene Oxide

The proposed maximum residue limit (PMRL) document for ethylene oxide and ethylene chlorohydrin notified in G/SPS/N/CAN/1125 (dated 12 July 2017) was adopted 18 October 2017. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

Ethylene Oxide:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

7 Herbs (crop subgroup 19A; dried leaves except dried basil leaves); spices (crop subgroup 19B)

Ethylene chlorohydrin:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

940 Herbs (crop subgroup 19A; dried leaves except dried basil leaves); spices (crop subgroup 19B)
