Established Maximum Residue Limit: Spirotetramat

The proposed maximum residue limit (PMRL) document for spirotetramat notified in G/SPS/N/CAN/1148 (dated 21 November 2017) was adopted 31 January 2018. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:
