Addendum

The following communication, received on 11 October 2018, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Methomyl

The proposed maximum residue limit (PMRL) document for methomyl notified in G/SPS/N/CAN/1180 (dated 18 July 2018) was adopted 9 October 2018. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

- 5.0 Succulent shelled peas
- 3.0 Broccoli
- 2.0 Brussels sprouts, cauliflowers
- 0.01 All food commodities (other than those listed in this item)²

¹ ppm = parts per million.

² This MRL replaces the currently established MRLs of 4.0 ppm for grapes, 2.0 ppm for lettuce, 1.0 ppm for strawberries and 0.5 ppm for apples.
