The following communication, received on 22 November 2018, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: 2,4-D

The proposed maximum residue limit (PMRL) document for 2,4-D notified in G/SPS/N/CAN/1195 (dated 22 August 2018) was adopted 19 November 2018. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.08 Undelinted cotton seeds

 1 ppm = parts per million
